## **SJWL General Meeting Minutes January 18, 2019**

**Call to order:** Valerie called the meeting to order at 7:06. She welcomed us and reminded us of the change of scheule in the meeting tonight.

**Devotion:** Allyson Sanders gave the devotion tonight. She gave her testimony that involved moving back to Sumter and leaving a job that she loved as a Pediatric Oncologist Nurse. Her testimony involved a boy named Russell who was 15 that was diagnosed with a brain tumor. After chemotherapy he had to relearn to walk and talk. After treatment, he was told that he had beat cancer, but he soon relapsed. Later he was asked to speak at an event for his church where he stood up in front of 200 people and gave his testimony telling of his faith in Christ. He referenced the verse Psalm 27:14. This boy's relenting faith reminds us of the verse Proverbs 3:5 Allyson reminded us that whatever challenges we may be facing, stop to see the goodness of God in it and trust in Him.

**President's Remarks:** Valerie James

Les Thompson introduced the speaker. He is in business relations for the hospital. He told of his own experience in the hospital with open heart surgery and cancer in his tonsils. He spoke of a nurse that took care of him and prayed with him when he wanted to resign after his health issues. He introduced this nurse as our speaker, Michelle Owens. Michelle spoke at the meeting to give us an update on Tuomey partnering with the Greenville hospital and being changed to Prisma. She claimed that the end goal for our hospital is to remain focused on the patients. She spoke of many accomplishments along with advancements going on in the hospital. They included the following: the hospital ER project will come to fruition, the Foundation is supporting the hospital and we are purchasing a robot, we will install a linear radiation to advance treatment, we are baby friendly, we are a breast imaging center of excellence, we have telehealth in schools, we have athletic trainers in 4 schools, we are partners with a local elementary school, Lemira, we support feed my starving children, and this year Michelle is chairing the heart walk. She brought 4 ladies with her for us to connect with. She introduced Shannon Cribb NP who helped open a clinic for heart failure from Columbia, and Shannon Cornell from Denver. In this clinic, they specialize in general cardiology along with advanced heart failure. Dr. Jill McLeod, who came back to Sumter from Dillon, with her husband. She has two boys. She is at Sumter OBGYN- an all-inclusive care facility. She touched on the new robotic surgery that with hysterectomys and added that the practice is branching off into the Manning area. Dr. Elizabeth Clark, a plastic surgeon, who specializes in Botox and fillers, breast reconstruction and reduction, cosmetic surgery, and offers a variety of skin care products. Michelle wanted to leave us with us feeling safe working in the Wishing Well, and that she considered us a part of the hospital's family and team. She pointed out that if we ever had a problem to contact her. Valerie thanked Michelle and the other doctors for coming and continued on with the meeting. She thanked Lisa and Jenny for the previous Lantern. She mentioned that our Sustainer representative, Kim Harrelson was pictured in the Lantern in our Legends section. Brownyn motioned that the minutes had been received and were correct, and Nancy Lee seconded. We voted to approve the minutes. Valerie read correspondence from the following local areas in our community that we support: Solomon's Home and Sumter Volunteer Services. She reminded us of the Spring art classes that will be available at the Sumter Gallery of Art.

Vicki received a proposal for a by-law change. The change is as follows: Hospital Gift Shop Regulations; Section 3 Wages A. (as written) Paid Workers are paid \$25.00 for any shift(s) that they work for members. (change to \$30) Reason: Our Wishing Well workers work hard to ensure that we have the time off that we need whenever possible. They have never had a pay increase, and this would let them know how much we value them, and their time.

The SJWL is proud to have three different groups volunteering with the Sumter United Ministries, SUM.

Placement A, chaired by Nancy Lee Zimpleman, helps with in office support such as greeting clients as they arrive, helping clients with the paperwork required for help and most importantly serving as Intakers. An intaker will meet with the SUM client in need, go over budget expenditures, what the need is and how SUM can help from paying a light bill to providing a box of food. Our initial review with the client and recommendation is processed by SUM for a decision on the services provide. While all that is important, the listening ear that we provide to someone seeking help is often what is most needed. The girls serving in Placement A are Leslie Horton, Kristin Sills and Jennifer Miller.



Placement B, chaired by Deanna Smith, coordinates projects, office work and other assistance as needed such as Thanksgiving Food Boxes and Christmas Angel Tree. These ladies write countless thank you notes to all the wonderful donations that are given to SUM, they cut angels and angels to help with Christmas, wrapped boxes and served in the lines at Thanksgiving and a multitude of other tasks on an as needed basis. These tasks are greatly beneficial since SUM operates on a very small staff and relies heavily on volunteers to keep all the details going. The girls serving in Placement B are Lauren Locklear, Ashley Reddick, and Jennifer Smith.

Placement C, chaired by Susan Weber, provides services to the new SUM Medical Clinic. This Free Clinic provides primary healthcare to qualifying patients who work hard but find health care financially out of reach. Our volunteers are able to assist the patients upon intake and most recently in the pharmacy area as patients are seen and provided with prescriptions. This allows the patients to be seen quickly and shown the care and support they need. The ladies serving in this placement are Mary Beth Skey and Heather Enzor.
