SJWL General Meeting Minutes

January 19, 2015

President Suzanne Palmer called the meeting to order at 7:00 PM and welcomed all members back after the holidays.

Ann Cannon shared the devotion. She spoke beautifully about the need for us all to have a servant's heart as we strive to serve the community of Sumter.

Suzanne asked the elected officers to share a little about their job description later in the meeting and encouraged members to consider serving in an elected position and to not take their names off the eligibility lists unless they are really sure they are unable to serve. She reminded everyone that February is a mandatory meeting.

The Lantern was emailed and should have been received by all. Everyone attending appeared to have received their copy.

The minutes from the November general meeting were provided through the Lantern. Mary Geddings made a motion to accept the minutes as written, and Nancy Lee Zimpleman seconded the motion. The motion passed.

Vice-President Mary Geddings reported that no proposals for by-law changes were received. Interest indicators for placements were put on tables for members to fill out. She explained that all members should give it some thought and fill them out. Mary Beth Mims asked which positions were considered your placement and which ones required a placement in addition to the position. Suzanne explained in most of the co-chair positions you would still have an additional placement. That does not apply however to the co-business manager placement. Suzanne also explained about cards on the tables listing needs of the United Ministries medical clinic. She explained that anyone could purchase and bring back those items at the next meeting.

Molly Matthews reported for Secretary Meg Hill that sustainer and semi-active status requests are due by February 1.

Assistant Secretary Molly Matthews announced that eligibility lists will be available at the end of the meeting if anyone would like to cross their name off the lists, and Sarah Smith had a new baby boy, John Austin.

Treasurer Dee Carraway had no report.

Assistant Treasurer Cindy Ardis announced \$497.10 donated to the Salvation Army from passing of the kettle.

Admissions Chair Susie Herlong reported that her committee met in December and the committee will meet again March 2 at 5:30. If you proposed someone you'll be called on for that day.

Community Research Chair Dibble Parker announced that her committee met and next meeting will report the grant disbursements.

Computer Chair Nancy Lee Zimpleman had no report.

Gift Shop Chair Gretchen Meyers reported that Christmas went very well. She said there were lots of new things coming in from market.

There is a new procedure for issuing a credit. Requests for credit should be left for the WW chair or co-chair to approve with the customer's name and number. The customer will be issued a credit on orange card stock.

Hospitality Chair Amy Moss had no report.

Lantern Editor Kelly Mills notified those from whom she needs articles and pictures.

Placement Council Chair Vicki Singleton reported that she had her Placement Council meeting and will report what placement recommendations were made at the next general meeting. She will also provide a refresher of the placement descriptions.

Provisional Chair Valerie James asked certain placements to stay and speak to the provisionals about their jobs.

Sustainer Representative Gayle Booth had no report.

Suzanne shared a brief description of being president of the SJWL. She said it was the easiest job she has done so far and is only called on if there is a problem. She explained approximately how many meetings she attends and how long they are. You get to know so many people and she highly recommends it.

Mary Geddings shared that the time spent in her role is similar to the President's and she gave a brief description of the job of bylaw changes and observing the president.

Suzanne shared that the Secretary is probably the most time consuming job in keeping the directory and updating and keeping the minutes.

Suzanne shared that the treasurer needs to be able to keep up with the checkbook, the budget, reports and reimbursements.

Molly shared that the assistant secretary keeps up with condolences and births, board schedule and board list.

Suzanne shared that the assistant treasurer passes the Salvation Army Kettle, sets up the emergency fund, and send out due reminder cards to sustainers and non residents.

Gretchen shared that the Wishing Well Chair job requires various amounts of time each week. The hours vary by the season. Some weeks could be 12-15 hours a week while others might be 3 hours a week. There are lots of texts and phone calls. She explained that part of her job is going to market and buying twice a year. She relies on her co-chairs and buyers for lots of help.

Old Business: none

New Business: Suzanne explained her concern about 85% of hours at the Wishing Well must be volunteer hours or we will have to pay income tax. This could mean that we would potentially pay \$10-15 thousand taxes. She explained that we should be fine this year if we can keep the number of paid workers to a minimum. She encouraged all members, if at all possible, to please try to keep your shift or switch with someone or ask another volunteer to work for you as opposed to getting a paid worker.

The next board meeting will be Feb 9. And the next general meeting will be Feb 16 and will be mandatory as we will be electing officers.

Mary Beth Mims said to keep in mind that you can switch with a paid worker and you don't have to pay them. You just trade.

Suzanne drew a number for someone to win a 40% off coupon at the Wishing Well. Lisa Andrews won.

Suzanne adjourned the meeting at 7:55 PM.


